

**BAUBAU BEACH STELLA MARINA REGULATION****Regional and Municipal seaside Ordinance and Provisions of AUSL of Rimini**

1. The area called "BAUBAU BEACH" is an area equipped for guests of STELLA MARINA accompanied by small and medium-sized pets accustomed to live with other animals and other people.
2. All dogs accessing the beach must have a health certification (vaccination booklet or other similar health document) certifying the annual vaccination against ectoparasites for no less than 20 days.
3. Dogs coming from abroad must meet the requirements, demonstrable through suitable documentation, provided for by EC Regulation n.576/2012 (pet passport).
4. Access to the BAUBAU BEACH is permitted only via marked route.
5. Animals are prohibited from stopping or walking on the beach outside of BAUBAU BEACH during the opening hours of STELLA MARINA Beach Village and dogs are prohibited from accessing the shoreline and the sea outside of the scheduled swimming times.
6. Swimming in the sea is permitted exclusively from 6:00 a.m to 7:30 a.m and from 7:30 p.m. to 9:30 p.m. only in the sea area limited to the shoreline in front of the beach equipped for the reception of animals, delimited by floating buoys and indicated by a special sign "Sea area for dog bathing" and only after animal registration at STELLA MARINA reception.
7. The animal owners must reach the sea area for animal swimming by passing along the identified path and keeping the animal on a leash which must have a maximum length of 1,5 mt.
8. During the dogs' stay in the sea, the presence of the owner must always be guaranteed and the dogs must never be left unattended and free to roam. Dog owners will have to clean water and the beach in case of animal excrement. After the bath, upon exiting the water, the dog must be immediately secured on a leash.
9. Animals are prohibited from accessing STELLA MARINA swimming pool and showers. Dogs are allowed access only to showers dedicated to them and appropriately indicated.
10. Dogs, subject to restrictive regulations regarding the protection of public safety, are prohibited from accessing the beach.
11. Dogs that, due to their temperament or character, prove to be dangerous or disturb the peace of the beach, are prohibited from staying. Access is prohibited to female animals in estrous period.
12. Dogs must always be kept on a leash while staying under the umbrella, all measures must be taken to guarantee the safety and tranquillity of other guests and other animals.
13. In case of incompatibility of dogs with other guests or with other animals or in case of incorrect behavior from their owners, the Management reserves the right to immediately remove them from the beach.
14. Guests are provided with the usual beach equipment (umbrella and sunbeds) and a bowl for water made of suitable material. The owners themselves will be responsible for finding the best accommodation for the well-being of their animals under the pertaining space of the umbrella.
15. Guests must take care to take their dog for a walk outside STELLA MARINA Beach Village; in case of excrement on the beach they must collect it immediately using a shovel and place it in special bags which must be closed and thrown into the waste bins pertaining to the area. The Management will be able to provide bags if guests do not have them.
16. Dog's owner is always responsible for the well-being, control and management of the animal and is liable both civilly and criminally for damage or injury to people, animals and things caused by the animal itself. The animals must be equipped with a muzzle (not worn) to apply in case of risk or at the request of the competent authorities. Insurance for damages to third parties is appreciated.
